

Utilities (Electricity, Telephone, Sewer/Water,	
Security System, Dumpster)	\$ 9,300
Real Estate Tax - Licenses	\$ 8,600
□ Insurances (Flood, Liability, etc.)	<u>\$ 7,900</u>
Total Annual Base Cost	\$55,800

Divided by our current 90 families = 620 per family per year merely to keep our doors open.

Dues Increases

□ Dues by Year:

- **2006:** \$375

- 2014 2017: \$520

Over the past 11 years dues have increased less than \$3/week

Financial Status

As of 10/31/16 – Total PYC money is \$62,605

- Savings balance is \$52,393
- Checking balance is \$5,391
- Cash for deposit is \$4,821
- There is \$4,000 in Security Deposits that must be returned

Club Performance as of 10/31/16

- Dues/initiation fees paid to date are \$44,976.
 - Budget projects \$46,467 at end of year
 - All member dues are paid
 - Budget plan assumes 90 members We have 90
- Income from operations is \$70,944 against a plan of \$60,275.
- Expenses are \$87,624 against a budget plan of \$82,753 that didn't included:
 - New kitchen/pantry air conditioner -- \$4,900
 - New ice maker -- \$3,800
 - Repairs to the dock -- \$4,700

Club Performance - continued

Membership growth is a big financial boost

- Lost 3 members and gained six new members to date

Booked rentals running above plan

- Last year we booked \$14,100
- To date this year we are at \$24,740
- The budget plan called for \$18,000

Mortgages

- Club's first mortgage
 - 10/31/2016 balance due is \$94,486
 - Current interest rate is 4.00%
 - Final reset will occur in January 2020 at prime + 0.75%.
 - Current monthly payment is \$1,134.76
 - Mortgage should be paid off on December 2024
- □ Moore & Moore 5-year balloon note
 - 10/31/2016 balance due is \$146,251
 - Current interest rate is 4.95%
 - Note to be reissued in August 2018 at prevailing rates.
 - Current monthly payment is \$1,368.37
 - Note should be paid off on July 2028

Availability of Money – Cash Flow

- □ The PYC Reserve is \$44,650.
- PYC's year-end "Cash Flow" outlay is \$11,000 more than the Profit-Loss statement indicates because:
 - Payments against Principal are about \$18,000
 - Depreciation expense of \$7,000 doesn't affect cash flow
 - Therefor the net income position is overstated by \$11,000


